MUNICIPAL ORDINANCE NO. 001  
Series of 1999

AN ORDINANCE CHANGING THE NAME OF QUIRINO STREET INTO CATALINO C. SABARICOS  
STREET AT SIAYAN, ZAMBOANGA DEL NORTE.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga  
del Norte in session assembled:

SECTION I. TITLE: This Ordinance shall be known as "AN ORDINANCE CHAN-  
GING THE MUNICIPAL STREET NAMED QUIRINO STREET INTO CATALINO C. SABARICOS STREET"  
at Siayan, Zamboanga del Norte.

SECTION II. SCOPE: Quirino street is located at the junction of Romero  
mills and Mr. and Mrs. Mauricio Sabaricos residence bound to the junction connec-  
ting the Provincial road passing agong creek going to Zamboanga del Sur.

SECTION III. DECLARATION OF POLICY: Quirino street is hereby changed and  
declared to be named Catalino C. Sabaricos street in Honor to the late Catalino C.  
Sabaricos to preserved his name to be remembered by the Siayanons due to his love,  
affection and generosity who donated a lot to the municipal government of Siayan,  
ZN. and conclusively as the first elected Municipal Vice-Mayor upon the creation  
of this municipality from the year 1968 and continued his unselfishly services up  
to the year 1980.

SECTION IV. REPEALING CLAUSE: All ordinance, rules and regulations in-  
consistent herewith are hereby repealed and modified accordingly.

SECTION V. EFFECTIVITY CLAUSE: That this ordinance shall take effect  
30 days after approval and publication of copies by posting at conspicuous places.
