MUNICIPAL ORDINANCE NO. 2000-01 Series of 2000

MAKING AVAILABLE THE AMOUNT OF FOUR HUNDRED FORTY FOUR THOUSAND TWO HUNDRED SEVENTY-THREE PESOS AND NINE CENTAVOS (P444,273.09) AS SUPPLEMENTAL BUDGET NO. 1 CY 2000 FOR PAYMENT OF CASH GIFT DIFFERENCE FOR YEAR 1999.

PREFATORY STATEMENT

After the closing of books of accounts for CY 1999, there was established an unappropriated surplus of P444,273.09 free of any encumbrances and obligations.

Budget Circular No. 11-B of the Department of Budget and Management authorized for the payment of P5,000.00 as Cash Gift for 1999 and years thereafter for all personnel of the local government unit. However, due to scarcity of funds, only P1,000.00 pesos was paid to employees during the year.

There being actual cash available at the end of the year 1999 as certified by the Municipal Treasurer and Municipal Accountant subscribed by the Local Chief Executive.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled.

Section 1. Title: That this Ordinance shall be entitled "An Ordinance Making Available the amount of FOUR HUNDRED FORTY FOUR THOUSAND TWO HUNDRED SEVENTY THREE PESOS AND NINE CENTAVOS (P444,273.09) as Supplemental Budget No. 1 CY 2000 for payment of Cash Gift difference for year 1999.

Section II. That the sum of P444,273.09 is actually available for appropriation which is free of any encumbrances and obligations.

Section III. That the amount of P444,273.09 is hereby appropriated and be made available for payment of Cash Gift difference CY 1999.

Section IV. That this Ordinance shall take effect upon approval.
