AN ORDINANCE RATIFYING THE FILING AND OTHER FEES PRESCRIBED IN

PREFATORY STATEMENT

Republic Act 9048 was an act authorizing the City or Municipal Civil Registrar or the Consul General to correct a clerical or typographical error in an entry of name and/or change of first name or nickname in the Civil Register without need of a judicial order.

The Act its implementation rules and regulations also authorized the City or Municipal Civil Registrar to collect reasonable fees from petitioners as a condition for accepting the petitions.

Administrative Order No. 1, Series of 2001, the Implementing Rules and Regulations of RA 9048, Rule 18, prescribed the amount of filing and other fees, of which this body hereby ratify. The fees shall form part of the new revenue sources.

BE IT ENACTED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: That this ordinance shall be entitled: "An Ordinance Ratifying the Filing and other Fees prescribed in Administrative Order No. 1, Series of 2001 the Implementing Rules and Regulations of RA 9048 for corrections of clerical or typographical error of name and/or Change of First Name or Nickname in the Civil Register without Judicial Order".

SECTION II. ORDAINING CLAUSE: That every petitioner be charged a filing fee as a condition for accepting the petition in an amount as follows:

SECTION III. REGULATED ACT. That the fees collected shall be form part of the local government's income and shall be included as new revenue sources in the Municipal Revenue Code.

SECTION IV. EFFECTIVITY CLAUSE: That this Ordinance Shall take effect upon its approval.
