"MUNICIPAL ORDINANCE NO. 05-01
Series of 2005

PREFATORY STATEMENT

The municipality of Siayan will be celebrating its 38th foundation anniversary on January 26-27, 2005. Usually during this time, more peddlers/travelers and any kind of business will be coming to install and display their goods, commodities and any kind of tiendas more or less one week. Considering the limited space and/or area within the premises of public market, the local government unit obliged to close some parts of the municipal roads and streets of Poblacion temporarily for them, the peddlers/travelers, vendors and other business operators to occupy.

The municipality of Siayan can generate more revenues from these business establishments for a short span of time hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled

SECTION I TITLE. This shall be known as "AN ORDINANCE EFFECTING THE TEMPORARY CLOSURE PART/PORION OF THE MUNICIPAL ROAD AND STREETS OF POBLACION DURING THE CELEBRATION OF ARAW NG SIAYAN, NAMELY ADAZA STREET, LADIAGONONG STREET, ALUMBRE STREET AND ABUNDIO B SIASICO SR. ST EFFECTIVE JANUARY 22-31, 2005.

SECTION II ORDAINING CLASUE. The following part/portion of municipal roads and streets are hereby temporarily close effective January 22-31, 2005. Sketch map is hereto attached which is form part of this ordinance.

1. Adaza St. - From the junction of Aguinaldo St up to the junction of Benlot St.
2. Ladiagonong St. - From the Junction of Provincial road up to the crossing of Abundio B. Siasico Sr. St.
3. Alumbre St. - From the junction of Provincial road up to the side of Municipal Library.
4. Abundio B. Siasico Sr. St. - From the junction of Alumbre St. up to the crossing of Ladiagonong St.

SECTION III ADMINISTRATIVE PROVISION: The portion of municipal roads and streets above-mentioned are temporarily close to any type of vehicles purposely for peddlers, vendors and any kind of business to be established therein. Provided however, that all types of vehicles could not be hindered on its route from any point of Poblacion due to existing roads and streets for their passage.


SECTION IV. PENAL PROVISION. Any person driving any type of vehicles who violates this ordinance shall be penalized a fine of P500.00 pesos but not more than P1,000.00 pesos or an imprisonment of 30 days but not more than 60 days or both at the discretion of the Honorable court.

SECTION V. EFFECTIVITY. This ordinance shall take effect upon approval


