PREFATORY STATEMENT

The Municipality of Siayan, Province of Zamboanga del Norte is celebrating its Founding Anniversary in every 26<sup>th</sup> and 27<sup>th</sup> day of January every year, based on its creation as a distinct municipality by virtue of RA 4989.

During this historical event, it will be highlighted a one week activities specially different sports competitions (inter-barangay), recognitions of past leaders who in one way contributed much in the development of this municipality, recognition of outstanding/model family in every barangay, Search for Miss Siayan, agro-industrial fair, competition of local wine making (Pangasi) and among others spearheaded by the LGU with participation of National Offices/agencies, NGOs and all others concerned.

The same occasion, it was practiced majority by the households/residents particularly employees to prepare foods, etc. to accommodate their respective visitors who came to observed the celebration, in which it cannot be denied that they can escaped from office and committed absences.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE DECLARING THE 26<sup>TH</sup> AND 27<sup>TH</sup> DAY OF JANUARY EVERY YEAR AS SPECIAL HOLIDAY OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That the 26<sup>th</sup> and 27<sup>th</sup> day of January every year is hereby declared as Special Holiday in the municipality of Siayan, Zamboanga del Norte.


SECTION III. ADMINISTRATIVE PROVISION. That during these days all offices/agencies national and/or local government units will render services if the necessity/exigency exist.

SECTION IV. EFFECTIVITY. That this ordinance shall take effect upon approval and posting of copies at conspicuous places and publication in official gazette.

APPROVED this 4<sup>th</sup> day of January 2007.


