DECLARING IN ORDER ORDINANCE NO. 02 OF DENUYAN AND THE SUPPLEMENTAL BUDGET NO. 02 CY 2009 BE DEEMED OPERATIVE EFFECTIVE UPON APPROVAL.

WHEREAS, forwarded before this august body for review and favorable action was Ordinance No. 02 of Denuyan authorizing for the passage of Supplemental Budget No. 02 CY 2009 in the amount of P188,193.00 representing IRA difference FY 2009;

WHEREAS, projects funded out of the 10% SK and 20% EDF are included in the approved plans of the barangay for the year 2009;

WHEREFORE, premise considered and on motion of Hon. Ephraim O. Melindo, duly seconded by all members present, it was

RESOLVED, as this body hereby resolved to declare in order Ordinance No. 02 of Denuyan and the Supplemental Budget No. 2 CY 2009 be deemed operative effective upon approval, **provided Section 325 of RA 7160 and LBC No. 75 shall be strictly observed.**

RESOLVED FINALLY, to furnish copies of this resolution to all offices concerned for information and favorable action.

Under other matters, Hon. Felizardo I. Gayapa, Sr. raised a privilege motion amending Municipal Ordinance No. 08-01, Series of 2008. No objection, thus it was carried, quoted hereunder:

**"MUNICIPAL ORDINANCE NO. 10-01
Series of 2008**

PREFATORY STATEMENT

The municipality of Siayan will be celebrating its 43rd founding anniversary on January 26-27, 2010. Usually during this time, more peddlers/travelers and any kind of business will be coming to install and display their goods, commodities and any kind of tiendas more or less one week. Considering the limited space and/or area within the premises of public market, the local government unit obliged to close some parts of the municipal roads and streets of Poblacion temporarily for the peddlers/travelers, vendors and other business operators to occupy.

The municipality of Siayan can generate more revenues from these business establishments for a short span of time hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE EFFECTING THE TEMPORARY CLOSURE PART/PORTION OF THE MUNICIPAL ROAD AND STREETS OF POBLACION DURING THE CELEBRATION OF ARAW NG SIAYAN, THE SAME TIME DESIGNATING THE PARKING AREA AND REGULATING THE ROUTE OF MOTOR AND FOUR (4) WHEEL VEHICLES WITHIN THE MARKET PREMISES OF POBLACION AMENDING MUNICIPAL ORDINANCER NO. 08-01.

SECTION II. MUNICIPAL ROADS/STREETS TEMPORARILY CLOSE: The following part/portion of municipal roads and streets are hereby temporarily close effective January 22-31, 2010 and year thereafter, sketch map is hereto attached which is form part of this ordinance.

1. Ladiagonong Street bound to the crossing of Abundio B. Siasico Sr. Street.
2. Alumbre Street bound to the Corner of Municipal Library..
3. Junction of Bentlot Street and National Highway is the entrance of any vehicles from North and South and will exit one way to Alumbre St. bound to Junction of National Highway and/or bound to the junction of Benlot Street down to Lanticse Street

4. Junction of Alumbre Street and Benlot Street from Lanticse Street is no entry to any kind of vehicles.
5. Adaza Street connecting Aguinaldo Street bound to the junction of Alumbre Street down to Lanticse Street vice versa is open to all kind of vehicle.
6. Ladiagonong St from the junction of Lanticse Street is no entry to all type of vehicles.

SECTION III. DESIGNATED PARKING AREA: The area at the back of the ABS Sr. Mini-gymnasium along or fronting Ladiagonong Street is hereby designated as the parking area of all motor vehicles habal-habal or private owned motor vehicles; and the area along the Abundio B. Siasico Sr. Street fronting the ABS Sr. Mini-gymnasium is hereby designated as the Parking Area of all types of four (4), six (6), and ten (10) wheelers vehicles;

SECTION III. ADMINISTRATIVE PROVISION: The portion of municipal roads and streets above-mentioned are temporarily close to any type of vehicles purposely for peddlers, vendors and any kind of business to be established therein and to prevent heavy traffic and vehicular accidents within the above-mentioned perimeters during the celebration of Araw ng Siayan;

SECTION IV. PENAL PROVISION. Any person driving any type of vehicles who violates this ordinance shall be penalized a fine of P500.00 pesos but not more than P1,000.00 pesos or an imprisonment of 30 days but not more than 60 days or both at the discretion of the Honorable court.

SECTION V. EFFECTIVITY. This ordinance shall take effect upon approval.

APPROVED this 14th day of January 2010.

Carried unanimously."

Since there being no further business before the Honorable Sangguniang Bayan in session assembled thus the chair declared session adjourned at 5:00 O'clock in the afternoon.




