"APPROPRIATION ORDINANCE NO. 2011-01 Series of 2011

PREFATORY STATEMENT

The Local Finance Committee has certified the availability of funds amounting to SIX MILLION NINE HUNDRED FORTY SIX THOUSAND FOUR HUNDRED FIFTEEN PESOS & TWENTY FIVE CENTAVOS (Php6,946,415.25) sourced from retained earnings FY 2010 which is free of any encumbrances and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF SIX MILLION NINE HUNDRED FORTY SIX THOUSAND FOUR HUNDRED FIFTEEN PESOS & TWENTY FIVE CENTAVOS (Php6,946,415.25) REPRESENTS RETAINED EARNINGS FY 2010 EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 FY 2011 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That the amount of SIX MILLION NINE HUNDRED FORTY SIX THOUSAND FOUR HUNDRED FIFTEEN PESOS & TWENTY FIVE CENTAVOS (Php6,946,415.25) is hereby made available for various expenditures of the local government unit. Statement of Supplemental Appropriation (LBP Form N0.10) is hereto attached as form part of this ordinance.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon the approval of the Sangguniang Panlalawigan of Zamboanga del Norte.
