**"MUNICIPAL ORDINANCE NO. 15-02  
Series of 2015**

**PREFATORY STATEMENT**

The previous legislators sometimes on November 2007 had acted Municipal Ordinance No. 07-18, dated November 22, 2007 prohibiting the transport of young carabaos aging 6 years old and below for slaughtering purposes and penalizing any violation thereof.

The intent of said Ordinance is to protect and preserve such serviceable carabao and to prevent from extinction or losses of this breed in the near future considering that the municipality of Siayan is an agricultural area, wherein 98% of the inhabitants are farmers that dependent on farm working animal.

The above-cited ordinance is hereby amended for the same intent, provided however to include all large cattle such as cow and horse for its production, consequently increasing its penalty in conformance with the thrusts and visions of the present administration to fight against poverty;

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

**SECTION I. TITLE.** This shall be known as "AN ORDINANCE PROHIBITING THE SELLING, BUYING, SLAUGHTERING AND TRANSPORTING OF YOUNG LARGE CATTLE AGING SEVEN (7) YEARS OLD AND BELOW OF THIS MUNICIPALITY AND PENALIZING ANY VIOLATION THEREOF, AMENDING MUNICIPAL ORDINANCE NO. 07-18, SERIES OF 2007."

**SECTION II. PROHIBITION.** It is hereby the policy to prohibit the selling, buying, slaughtering and transporting of young large cattle aging seven (7) years old and below outside the municipality of Siayan, Zamboanga del Norte;

**SECTION III. AUTHORITY TO SELL.** Selling in any kind of live large cattle covered in this ordinance for agricultural and breeding purposes is hereby authorize, provided however, between the inhabitants of this municipality only.

**SECTION IV. AUTHORITY TO SLAUGHTER.** Slaughtering in any kind of large cattle herein covered is hereby authorized. Provided however, it is public notified or certified as disable, provided further that transporting of meat outside the municipality of Siayan is strictly prohibited and the same it is a violation of this Ordinance

**SECTION V. ADMINISTRATIVE PROVISION.** The following is the consent in the apprehension of violators:

- a) The buyer violator upon payment of the penalty herein imposed under the 1<sup>st</sup> and 2<sup>nd</sup> offense shall return the large cattle to the owner, at the same time the seller/owner violator upon payment the corresponding penalty herein imposed under the 1<sup>st</sup> and 2<sup>nd</sup> offense shall return the paid money to the buyer.
- b) If both the seller/owner and the buyer violators shall be penalized under the 3<sup>rd</sup> offense, the provision of Section V, Paragraph (a) shall be applied however the local government unit shall take charge for the transport of his large cattle going back to his family. If such violator has no family he has the option to sell his large cattle to the local government unit and/or to the interested inhabitants of this municipality.

**SECTION VI. PENALTY.** Any violation of this ordinance both the seller/owner or buyer and the transporter shall be penalized in the following manner:

1<sup>st</sup> Offense \_\_\_\_\_ P4,000.00  
2<sup>nd</sup> Offense \_\_\_\_\_ 4,500.00  
3<sup>rd</sup> Offense \_\_\_\_\_ 5,000.00  
plus imprisonment of 30 days but not more than 60 days  
or at the discretion of the Honorable Court.

**SECTION VII. REPEALING CLAUSE.** That Municipal Ordinance No. 07-18, dated November 22, 2007 is hereby repealed


**SECTION VIII. EFFECTIVITY.** – This ordinance shall take effect 30 days after approval of the Hon. Sangguniang Panlalawigan of Zamboanga del Norte, posting of tarpaulin and publication of copies in any of general circulation.


