MUNICIPAL ORDINANCE NO. 02  
Series of 1998

ORDINANCE REVERTING THE AMOUNT OF SIX HUNDRED NINETY ONE THOUSAND EIGHT HUNDRED ONE PESOS AND SIXTY THREE CENTAVOS (P691,801.63) FERTILIZER ASSISTANCE REVOLVING FUND FOR ADDITIONAL ALLOCATION FOR THE PURCHASE OF DUMPTRUCKS.

PREFATORY STATEMENT

The Local Government Unit of Siayan, Zamboanga del Norte initiated a fertilizer assistance program last year with one million investment. The amount was intended as revolving fund to be released to marginal farmers as initiative capital to enhance food production.

Closing financial statement of the municipality for the year ended 1997 disclosed a repayment of P691,801.63. Complementary to the increase in production is the necessity of constructing all weather barangay roads. The construction was made possible with the acquisition of a bulldozer. However, maintaining it to a year round passable condition cannot be done without the use of dumptrucks.

The Local Government Unit resorted to borrowings for the purchase of dumptrucks and wheel loader but the increase in dollar kindered the agency to buy the intended numbers of equipment.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

SECTION 1. TITLE: This Ordinance shall be entitled and known as ORDINANCE REVERTING THE AMOUNT OF P691,801.63 FERTILIZER ASSISTANCE REVOLVING FUND FOR ADDITIONAL ALLOCATION FOR THE PURCHASE OF DUMPTRUCKS.

SECTION 2. ORDAINING CLAUSE: That the amount of SIX HUNDRED NINETY ONE THOUSAND EIGHT HUNDRED ONE PESOS AND SIXTY THREE CENTAVOS (P691,801.63) fertilizer assistance revolving fund shall be reverted for additional allocation for the purchase of dumptrucks.

SECTION 3. EFFECTIVITY CLAUSE: That this ordinance shall take effect on January 1, 1998.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Ilocos Norte in session assembled:
