AN ORDINANCE CHANGING THE NAME OF MUNICIPAL STREETS AT SIAYAN, ZAMBOANGA DEL NORTE FROM THE NATIONAL FIGURES AND NAMING INTO THE PAST LOCAL OFFICIALS AND PAST DONORS OF REAL PROPERTY OF THE LOCAL GOVERNMENT UNIT OF SIAYAN ZAMBOANGA DEL NORTE.

Prefatory Statement

Various municipal streets at Siayan proper, the Poblacion upon its creation were recognized and named mostly in honor to the national heroes and to the Past President of the Republic of the Philippines.

The municipality of Siayan reached its present image due to the unvaluable services with dedication of the past local officials and through the love, sentiment and generosity of the past donors of their real property to the local government.

Changing the name of municipal streets is just and fair in honor to our local past officials and past donors of real property to commemorate their names who in one way primarily contributed the development of Siayan, were as follows:

Late Feliciano E. Castillo - donor of lot for National High School;
Barangay Captain (1968-1972); Sangguniang Bayan Member (1972-1979)

Late Awani Sango - donor of municipal lot

Late Santos A. Calumpang - Barangay Councilman (1968-1972); Barangay Captain (1972-1982) and donor of Municipal Lot.

Late Calilang Sibuco - donor of municipal lot.

Late Celes Tigong - donor of municipal lot (Sports center)

WHEREFORE, BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

SECTION I. TITLE: This ordinance shall be known as "An Ordinance Changing the name of Municipal Streets of Siayan, ZN from the National Figures and naming into the past local officials and past donors of real property to the local government Unit of this municipality.

SECTION II. SCOPE: The following streets are as follows:

- 1) Mabini Street. - located beginning from the provincial road bound to Rizal park fronting the Municipal Hall passing between the municipal hall and legislative building ended Jose Lanticse Street.
- 2) Rizal Street - Located beginning from provincial road bound to Siayan Central Elementary School.
- 3) Osmeña Street- located beginning from provincial road bound and ended Jose Lanticse Street passing between Vice Mayor Ephraim O. Melindo and SPO3 Alejandro Castillo Residence.
- 4) Roxas Street - located beginning from provincial road bound to the side of Jimmy Tolentino residence ended Jose Lanticse Street near Teodosia Calapiz residence.
- 5) Quezon Street - located beginning from the provincial road bound and ended Jose Lanticse street passing Reynaldo Secretario residence.
- 6) Newly created Municipal Street - located beginning from the provincial road passing Felipe Alumbre agricultural land bound and ended to Rizal Street passing Mr. Rodolfo Parreño residence.

SECTION III. DECLARATION OF POLICY: That the above-mentioned municipal streets are hereby change and name into the following:

1. Mabini Street - be change into Rizal Street.
2. Rizal Street - be change to Calilang Sibuco Street.
3. Osmeña Strret - be change to Feliciano E. Castillo Street.
4. Roxas Street - be change to Santos Calumpang Street.
5. Quezon Street - be change to Celes Tigong Street.
6. the new created municipal Street - shall be named into Awani Sango Street.


SECTION IV. REPEALING CLAUSE: All ordinances and regulations inconsistent herewith are hereby repealed and modified accordingly.

SECTION V. EFFECTIVITY: That this ordinance shall take 30 days after its approval and publication to and posting of copies to conspicuous places.




