"MUNICIPAL ORDINANCE NO. 00-02  
Series of 2000

**AN ORDINANCE REVISING THE MUNICIPAL REVENUE CODE IN THE MUNICIPALITY  
OF SIAYAN, ZAMBOANGA DEL NORTE.**

BE IT ORDAINED, by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled that, the Municipal Ordinance No. 004, series of 1994 otherwise known as the Revised Municipal Revenue Code of Siayan, Zamboanga del Norte be revised to conform with the present imposition of taxes, permits of trade, commerce and industry and other revenues and to incorporate the Municipal Taxation Ordinances enacted by the Sangguniang Bayan of this municipality in accordance to the provisions of Republic Act 7160 known as the Local Government Code of 1991.

**CHAPTER I – GENERAL PROVISION**

**ARTICLE A. – TITLE AND SCOPE**

**SECTION 1A.01 – TITLE:** This Ordinance shall be known as the Municipal Revenue Code of 2000 of the municipality of Siayan, Zamboanga del Norte Philippines.

**SECTION 1A.02 – SCOPE:** This code shall govern the levy, assessment and collection of taxes, fees, charges and other imposition within the jurisdiction of the municipality of Siayan, Zamboanga del Norte.


All other matters, relating to the provisions in this code shall be govern by the pertinent provisions of existing laws and other ordinance;


**Section 7A.04. EFFECTIVITY CLAUSE;**


This Code shall take effect Sixty days (60) days after approval, publication of copies by posting to conspicuous place furnished to all concern;


