FINDINGS:

- a) Barangay Balok and Diongan like other barangays of the municipality of Siayan have its aim and purpose to achieve development for the welfare of the people, however it is very difficult for the realization of their planned projects without the support and assistance from outside sources.
- b) With the launching of the KALAHI-CIDSS-KKB program in coordination of the DSWD the realization of community identified projects are now possible through counterparting or sharing scheme.
- c) The intent of Resolution No. 01 of Balok and No. 03 of Diongan are good and laudable it interpose no objection but rather express strong and favorable support for the programs/aims of the KALAHI-CIDSS-KKB as special project of the DSWD.

The Committee recommended that Resolution No. 01 of Balok and Resolution No. 03 of Diongan be entered in the calendar of business for second reading. The Committee's recommendation was adopted.

PREFATORY STATEMENT

The Closing trial balances CY 2004 reflects retained earnings of TWO MILLION FIVE HUNDRED SIXTY THREE THOUSAND TWO HUNDRED TEN PESOS AND NINETY FIVE CENTAVOS (Php 2,563,210.95) plus grants and aids from the provincial government in the amount of ONE MILLION PESOS (Php 1,000,000.00) a total of THREE MILLION FIVE HUNDRED SIXTY THREE THOUSAND TWO HUNDRED TEN PESOS AND NINETY FIVE CENTAVOS (P3,563,210.95).




