"MUNICIPAL ORDINANCE NO. 06-02  
Series of 2006

PREFATORY STATEMENT

In the annual celebration of the founding anniversary of the municipality of Siayan, Province of Zamboanga del Norte in every 26-27<sup>th</sup> day in the month of January, more people from the barangays, visitors, business operators and among others will be coming, therefore it occurs traffic irregularities in the municipal roads and streets within the municipal public market located at barangay Poblacion due to the presence of vehicles, private-owned or public utility plus the buying public.

The entrance to and/or exit from the public market premises of any directions along the municipal roads and streets might cause danger and to prevent vehicular accidents hence this enactment.

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled

SECTION I. TITLE. This shall be known as "AN ORDINANCE EFFECTING THE TRAFFIC SCHEME THEREFORE ESTABLISHMENTS OF PRESCRIBED TRAFFIC SIGNS AND TEMPORARY CLOSURE OF THE MUNICIPAL ROADS AND STREETS OF BARANGAY POBLACION, DURING THE ANNUAL FOUNDING ANNIVERSARY CELEBRATION OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE AND PENALIZING ANY VIOLATORS THEREOF".

SECTION II. TRAFFIC SCHEME: That the traffic signs shall be established in the following municipal roads/ streets of Poblacion, Siayan, Zamboanga del Norte, attached hereto is sketch map which is form part of this ordinance:

1. Along Sindangan - Siayan provincial road thence to Alumre Street "No Entry"
2. Along Sindangan - Siayan provincial road thence to Benlot Street will be the entrance going to the public market with traffic sign "This Way"
3. Alumre Street is one way;
4. Along Lantise Street entering Alumre Street thence to the fish vendor corner is "No Entry"
5. Benlot Street thence to Siayan - Sindangan Provincial Road is "No Entry"
6. At the corner of the concrete pavement in front of the Municipal Library approaching Alumre Street is "No Entry"
7. At the street connecting Alumre Street and Benlot Street between the new and old market building is "No Entry"
8. The Adaza Street connecting Aguinaldo Street and Benlot Street thence to Alumre street and Lantise Street shall be temporary close,

SECTION III. PENALTY. That any violators of this ordinance shall be penalized in the amount of P200.00 but not more than P500.00 and/or imprisonment at the discretion of the honorable court.

SECTION IV. REPEALING CLAUSE: Any Ordinance inconsistent to the provision of this ordinance is hereby amended and repealed.

SECTION III. That this Ordinance shall take effect every celebration of the founding anniversary of the Municipality of Siayan, Zamboanga del Norte.




