MINICIPAL ORDINANCE NO. 03-001 MAKING AVAILABLE THE AMOUNT OF THREE MILLION TWO HUNDRED MUNICIPAL ORDINATION OF THE INDICENTAL PRINCIPAL PRINCIP EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 CY 2003 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

PREFATORY STATEMENT

The Local Government Unit of Siayan, Zamboanga del Norte accumulated the amount of Three Million Two Hundred Sixty Eight Thousand Seven Hundred Seventy Six Pesos and Fifty Seven Centavos (P3,268,776.57) representing the imappropriated surplus of the previous years which is free of any encumbrances or obligations whatsoever duly certified by the appropriated surplus of the previous years which is nee of any encumbrances of configurous whatsoever the Local Chief Executive Horl.
