PREFATORY STATEMENT

Upon the effectivity of RA 7160, known as the "Local Government Code of 1991", the services and personnel including its emolument of the Department of Agriculture was devolved to the Local Government Unit.

As mentioned under Title Five, Section 481, Article Twelve of RA 7160, one of the appointive local officials common to all municipalities and provinces is Municipal Agriculturist.

In the delivery of basic services concerning agriculture in this municipality, the Municipal Agricultural Officer (MAO) acted as the Head of the Municipal Agriculture Office in which having a similar duties and functions of the Municipal Agriculturist (MA) as provided in the

In full effect of devolution mandated under the Local Government Code, the position of Municipal Agricultural Officer (MAO) with a salary Grade 20 is hereby upgraded into Municipal Agriculturist (MA), MGDH I, with a salary Grade 24, with this upgrading, the position of MAO is hereby dissolved considering that the functions are similar.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. SECTION III. EFFECTIVITY. That this ordinance shall TAKE EFFECT ON January 1, 2003.
