

**"MUNICIPAL ORDINANCE NO. 15-03
Series of 2015**

PREFATORY STATEMENT

Local Government Units has the power to create sources of revenues provided under Book II, Chapter I, Section 129 of RA 7160 known as the Local Government Code of 1991.

One (1) of these source of revenues is the Transport Permit of mineral Ore extracted in this municipality by various mining firms, however, the amount imposed under Municipal Ordinance No. 12-01, Series of 2012 known as the Municipal Revenue Code is too minimal that necessitates to be increased hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "MUNICIPAL REVENUE ORDINANCE IMPOSING TRANSPORT PERMIT FEE OF ALL KINDS OF MINERAL ORE EXTRACTED WITHIN THE JURIDICAL TERRITORY OF THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE. AMENDING ARTICLE H, SECTION 177, NO. (1) OF MUNICIPAL REVENUE CODE.

SECTION II. IMPOSITION OF FEES AND CHARGES. It is hereby collected a TRANSPORT PERMIT FEE in the amount of Ten (P10.00) pesos per ton of all kinds of mineral ore extracted from the municipality of Siayan, Zamboanga del Norte.

SECTION III. ADMINISTRATIVE PROVISION. The Municipal Treasurer or his duly authorized representative shall keep a ledger controlling all cargo trucks loaded of mineral ore with its plate numbers, name of driver/operator and number of tons to determine the corresponding fees and charges to be collected.

The Municipal Treasurer shall send a notice of payments to the operators, and the latter five (5) days after receiving the notice, and the payments shall be made in the Office of the Municipal Treasurer likewise official receipt shall be issued.

SECTION IV. PENALTY. Any violation of this ordinance shall be penalized in the amount of P2,000.00 and/or such cargo truck is prohibited to operate in hauling mineral ore as provided in this ordinance.


SECTION V. EFFECTIVITY. This ordinance shall take effect upon approval.




