AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF ONE MILLION TWO HUNDRED EIGHTY THOUSAND FOUR HUNDRED FIFTY SIX PESOS AND SIXTEEN CENTAVOS (\$1,280,456.16) REPRESENTING THE UNAPPROPRIATED SURPLUS CY 1998 EMBODIED IN SUPPLEMENTAL BUDGET CY 1999 FOR THE PAYMENT OF AMELIORATION ASSISTANCE, ADDITIONAL CASH GIFTS AND ALLOCATION FOR MAINTAINANCE AND OTHER OPERATING EXPENDITURES (MODE) OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled:

SECTION I. TITLE AND PURPOSE: This Ordinance shall be entitled "An Ordinance Making Available the Amount of One Million Two Hundred Eighty Thousand Four Hundred Fifty Six Pesos and Sixteen Centavos (F1,280,456.16) representing the unappropriate balance CY 1998 embodied in Supplemental Budget CY 1999 for the payment of amelioration assistance, additional cash gifts and allocation for Maintaninance and Other operating Expenditures (MOOE) of the Local Government Unit of Siayan, Zamboanga del Norte.

SECTION II. APPROPRIATION ACT: That the amount of ONE MILLION TWO HUNDRED EIGHTY THOUSAND FOUR HUNDRED FIFTY SIX PESOS AND SIXTEEN CENTAVOS (F1,280, 456.06) shall be made available for payment of amelioration assistance, additional cash gifts and allocation of MODE embodied in Supplemental Eudget No. 1 CY 1999.

SECTION III. EFFECTIVITY: That this ordinance shall take effect on January 1. 1999.
