## MUNICIPAL ORDINANCE NO. 00-003 Series of 2000

MAKING AVAILABLE THE AMOUNT OF ONE MILLION EIGHT HUNDRED FIFTY EIGHT THOUSAND TWO HUNDRED NINETY-NINE (P1,858,299.00) PESOS AS SUPPLEMENTAL BUDGET NO. 2 CY 2000 FOR VARIOUS EXPENDITURES IN THE GENERAL FUND OF THE MUNICIPALITY.

## PREFATORY STATEMENT

New Sources of revenues such as borrowings and the 2<sup>nd</sup> tranche of the LGSEF are available which are subject to budgeting. The amount of One Million Five Hundred Pesos (P1,500,000.00) is secured from PNB-Sindangan Branch as equipment loan for the purchase of reconditioned road grader and motorcycle to be used in the monitoring activities while undertaking road construction/rehabilitation works. The amount of Three Hundred Fifty Eight Thousand Two Hundred Ninety-Nine Pesos (P358,299.00) represents the 2<sup>nd</sup> Tranche of the Local Government Service Equalization Fund (LGSEF). The funds shall be appropriated and disbursed according to its standard process.

Section I – That the title shall be "Appropriation Ordinance Making Available the Amount of One Million Eight Fifty Eight Thousand Two Hundred Ninety Nine (P1,858,299.00) Pesos as Supplemental Budget No. 2 CY 2000.

Section II – That the amount shall be appropriated for the purchase of reconditioned road grader including its upkeep and maintenance; brand new motorcycle including its inherent and incidental costs; payment of additional cash gift and such other contractual and statutory expenses embodied in Supplemental Budget No. 2 CY 2000 herein adopted and authorized;

Section III - That this Ordinance shall take effect upon its approval.
