AN ORDINANCE PROHIBITING MINORS AGING EIGHTEEN (18) YEARS OLD TO AUDIENCE AND ENGAGE BETTING IN COCKFIGHTING IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

PREFATORY STATEMENT

As observed, minors below eighteen years old (18) usually audience and engaged betting in hack fighting. This game of chance is detrimental and destructive on their studies and habits.

Mostly, wealthy and/or poor children influenced in any type of gambling are la_y to go to school and maybe some might involve in crimes particularly thefts, robbery, and hold-ups just to earn for their capital.

This Ordinance shall be imposed to prevent minors to be influenced in gambling and involved any crimes for their welfare and bright future.

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled:

SECTION I. This Ordinance shall be known as An Ordinance prohibiting minors aging below eighteen (18) years old to audience and engage betting in any hack fight in the municipality of Siayan, Zamboanga del Norte.

SECTION II. All minors aging below eighteen (18) years old is strictly prohibited to audience and engage betting in any hack fighting in the municipality of Siayan, Zamboanga del Norte.

SECTION III. Any violations hereof shall be penalized in the amount of THREE HUNDRED (300.00) PESOS BUT NOT MORE THAN FIVE HUNDRED (P500.00) PESOS AND/OR IMPRISONMENT OF THIRTY (30) days but not more than SIXTY (60) days and or both penalty and imprisonment upon the discretion of the Honorable Court.

SECTION IV. This Ordinance shall take effect SIXTY (60) days after approval and publication of copies at conspicuous places.

APPROVED THIS 1st day of February, 2001.

Under other matters, the Hon. Presiding Officer Ephraim O. Melindo informed the Sangguniang Bayan members that two (2) identified leaders from Sitio Gigang and Sitio Suminogod of Guibo this municipality in the person of Mr. Agdino Dadan and Mr. Alejandro Mangubot be presented before this august body in session assembled to affirmed their agreement likewise solicited the full support of the legislators on their endeavor.

Primarily, the above-mentioned individuals were urging for the creation of their respective sitios into a barangay, unfortunately, their efforts and/or struggle could not be realized unless one of them will yield to meet the population requirements.

At this juncture, Hon. Rudy S. Dominase moved to suspend the rule in the order of business, in this Mr. Dadan and Mr. Mangubot could participate the discussions. Duly seconded by Hon. Nilo T. Pollescas, no objection thus the motion to suspend the rule was carried.

Eventually, Mr. Alejandro Mangubot inclined in favor to sitio Gigang, and his affirmation was supplemented with affidavit waiving his interest for the creation of Sitio Suminogod into a barangay.

SECTION III. Any violations hereof shall be penalized in the amount of THREE HUNDRED (300.00) PESOS BUT NOT MORE THAN FIVE HUNDRED (P500.00) PESOS AND/OR IMPRISONMENT OF THIRTY (30) days but not more than SIXTY (60) days and or both penalty and imprisonment upon the discretion of the Honorable Court.

SECTION IV. This Ordinance shall take effect SIXTY (60) days after approval and publication of copies at conspicuous places.

Vice Mayor Melindo advised that the arrangement or the agreement of the duo shall be indorse to the Sangguniang Barangay of Guibo, in like manner, the Sangguniang Barangay of Guibo will recommend thru a resolution for the creation of Sitio Gigang into a barangay to be submitted before this august body consequently for proper disposition.

Then the rule in the order of business were resumed. Since there being no further business before the Sangguniang Bayan in session assembled, and on motion of Hon. Inocencio A. Limbang duly seconded by Hon. Rudy S. Dominise, thus the regular session was adjourned at 5:00 O'clock in the afternoon.


