FINDINGS:

PREFATORY STATEMENT

Records showed that at the end of Calendar Year 2001, there were various undertakings funded, implemented and completed yet funds are outstanding remaining and no longer needed for the particular activities for which it was originally intended. As has been recommended by the Local Chief Executive, the funds can be reverted to more priority and necessary activities for a more effective delivery of services. In compliance with Sec. 332 of RA 7160 otherwise known as the Local Government Code of 1991, hence this reversion.



RESOLVED FINALLY, to give copies of this resolution to the Hon. Provincial Governor for information and appropriate action.




Since there being no further business before the Hon. Sangguniang Bayan in session assembled, thus the chair declared session adjourned at 5: 00 O'clock in the afternoon.


