

- d. The area covered of the industrial sand and gravel exploration of Mr. Karl Vincent T. Siastico is approximately 10 hectares partly located from sitio Lupot of Poblacion to Paranglumba and barangay Litolet of this municipality,
- e. He further informed that as per records of the Mines and Geo-science Bureau, Regional Office No. 9, Zamboanga City, no person, company and/or any firm has been granted for industrial sand and gravel exploration in the municipality of Siayan.
- f. The municipality of Siayan shall accrue income through its taxes and other regulatory fees of this sand and gravel exploration.

The committee recommends for inclusion in second reading. The Committee's recommendation was adopted.

3. **RESOLUTION NO. 08 OF PARANGLUMBA SERIES OF 2006 INTERPOSING NO OBJECTION FOR THE ESTABLISHMENT OF WASHING PLANT AT BARANGAY PARANGLUMBA, SIAYAN, ZAMBOANGA DEL NORTE**

FINDINGS:

- a. Resolution No. 08 of Paranglumba is expressing no objection for the establishment of washing plant.
- b. Based on the barangay consultative assembly meeting held at said barangay, it was learned that washing plant for copper and other metallic and non-metallic ores except gold is not dangerous to the community considering that no poisonous chemicals shall be use instead purely water.

The committee recommends for 2nd reading. The Committee's recommendation was adopted.

MEASURES CONSIDERED AND APPROVED IN THE PREMISE OF SECOND READING ARE QUOTED HEREUNDER:

**"MUNICIPAL ORDINANCE NO. 03
Series of 2006**

Section 43 of RA 6975 otherwise known as the "Department of Interior and Local Government Act of 1990" provides for the creation of People's Law Enforcement Board (PLEB) in every municipality to conduct hearing and adjudication of citizen's complaints against uniformed member of the PNP for offenses committed in their area of jurisdiction.

Anent thereto, the PNP personnel itself in preparing/processing pertinent papers, for promotion, retirements or whatsoever, one of the requirements is a PLEB clearances.

In the delivery of the PLEB duties and functions it will incur expenses particularly office supplies and among others, thus to accumulate a mere income to substitute its various expenditures hence, imposing fees or charges in the issuance of PLEB Clearance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled.

SECTION I. TITLE. This shall be known as "AN ORDINANCE IMPOSING FEES AND CHARGES IN THE ISSUANCE OF PLEB CLEARANCE TO THE PNP PERSONNEL".

SECTION II. ORDAINING CLAUSE. There shall be collected fees and/or charges in the amount of Fifty (P50.00) pesos to the PNP Personnel who may secure clearance from the office of the PLEB.


