PREFATORY STATEMENT

The Finance Committee has certified to the availability of funds in the amount of P11,541,389.28 sourced from IRA difference CY 2006 which is free of any encumbrances or obligations whatsoever subject for appropriation embodied in Supplemental Budget No. 01 CY 2007 to defray various expenditures in the operation of the local government unit of this municipality, hence this ordinance

BE IT ORDAINED by the Sangguniang Bayan in session assembled.

SECTION I. TITLE. This shall be known as "AN APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF ELEVEN MILLION FIVE HUNDRED FORTY ONE THOUSAND THREE HUNDRED EIGHTY NINE PESOS & TWENTY EIGHT CENTAVOS (P11,541,389.28) EMBODIED IN SUPPLEMENTAL BUDGET NO. 01 CY 2007 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT".

SECTION II. ORDAINING CLAUSE: That the amount of P11,541,389.28 embodied in Supplemental Budget No. 01 CY 2007 is hereby made available to defray the following expenditures, reflected in different LBP Form No. 161-A, LBP Form No. 161 and LBP No. 3 hereto attached as form part of this Ordinance.
