"MUNICIPAL ORDINANCE NO. 04-002
Series of 2004

PREFATORY STATEMENT

Basically, rubber latex after having gathered from the field shall be treated with acids and other compounding agents to form into solid particles a raw materials prior manufacturing into rubber products, however it causes **bad odor** particularly thoroughly wet saturated in the water for a spair of time.

In time of marketing, it was observed that cargo trucks from other municipalities carrying with compounded rubber latex, usually passed and sometimes overnight parked along the provincial road within the town site and sometimes near the vicinity of market site and the children's playground in which the **bad odor** brought by the rubber latex will spread throughout the different establishments like restaurants/carenderia, stores, etc and neighboring houses which is injurious to everybody's health.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE PROHIBITING ANY CARGO TRUCKS CARRYING A RUBBER LATEX TO PARK ALONG THE PROVINCIAL ROAD AND MUNICIPAL ROAD/STREETS WITHIN THE TOWN SITE/ MARKET SITE, CHILDREN'S PLAYGROUND OF POBLACION, SIAYAN, ZAMBOANGA DEL NORTE FOR SANITARY PURPOSES AND PENALIZING ANY VIOLATION THEREOF".

SECTION II. ORDAINING CLAUSE: Any vehicles/cargo trucks carrying rubber latex is hereby prohibited to park along the provincial road and municipal road/streets within the town site/market site, children's playground of Poblacion, Siayan, Zamboanga del Norte and penalizing any violation thereof.

SECTION III. EXEMPTION: Unintentional parking in the above-mentioned area due to flat tire, engine trouble and/or vehicular accident is exempted in the provision of this ordinance. Attached is the road network map of Poblacion, Siayan, ZN which is form part of this ordinance.

SECTION IV. PENALTY CLAUSE: Any driver/operator of the vehicles/cargo trucks herein mentioned who violates this ordinance shall be fined in the amount of P500.00 pesos but not more than P1,000.00 pesos, and imprisonment of 30 days but not more than 60 days and/or at the discretion of the Honorable Court.


APPROVED, this 13th day of May 2004.

Since there being no further business before the Honorable Sangguniang Bayan in session assembled, thus the Chair declared session adjourn at 5:00 O'clock in the afternoon.


