

"ORDINANCE NO. 04-004
Series of 2004

PREFATORY STATEMENT

The Local Government Unit had accumulated the amount of P4,032,092.11 pesos representing retained earnings in the closing of trial balances CY 2003 which was appropriated for various expenditures embodied in Supplemental Budget No. 01, CY 2004 and the same was made available under Mun. Ordinance No. 04-001, Series of 2004.

In line with the plans and programs of the municipal government to establish an integrated bus terminal, the amount of P500,000.00 part of the retained earnings above-cited was appropriated for the purchase of land for the purpose, unfortunately, it was erroneously entered as **Land Improvement** in the preparation of Supplemental Budget reflected in the Program Appropriation and Obligation by Object (Local Budget Preparation Form No. 152) covered under the non-office expenditures Item of the Office of the Municipal Mayor, wherein, the title is supposed to be is **LAND** only.

The procurement of land could not be processed since it is in violation with the New Government Accounting System (NGAS) in utilizing such appropriation above-mentioned hence this enactment.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. THIS SHALL BE KNOWN AS "AN ORDINANCE AMENDING "LAND IMPROVEMENT" INTO LAND" SIMULTANEOUSLY ITS CORRESPONDING AMOUNT OF P500,000.00 PESOS REFLECTED ON THE PROGRAM APPROPRIATION AND OBLIGATION BY OBJECT (LOCAL BUDGET PREPARATION FORM NO. 152) EMBODIED IN SUPPLEMENTAL BUDGET NO. 1, CY 2004, COVERED UNDER THE NON-OFFICE EXPENDITURES OF THE OFFICE OF THE MAYOR".


SECTION II. ORDAINING CLAUSE. That the appropriation for "**Land Improvement**" in the amount of P500,000 pesos, reflected in Program Appropriation and Obligation by Object (Local Budget Preparation Form No. 152, embodied in Supplemental Budget No. 1, CY 2004, covered under the Non-office expenditures in the Office of the Mayor, is hereby amended into "**Land**". All forms used in its amendments are form part of this ordinance.

SECTION III. EFFECTIVITY. This ordinance shall take effect upon approval of the Hon. Sangguniang Panlalawigan, and publication in official gazette and posting of copies at conspicuous places.



Since there being no further business before the Honorable Sangguniang Bayan in session assembled, thus the chair declared session adjourned at 5:00 O'clock in afternoon.


