## PREFATORY STATEMENT

The Local Government Unit of Siayan, Zamboanga del Norte through its Supplemental Budget preparation has lumpsum appropriations the amount of \$\mathbf{F}843,091.00 under Supplemental Budget No. 2, Calendar Year 1997 and the amount of \$\mathbf{F}321,330.20 under Supplemental Budget No. 1 Calendar Year 1998 with a total amount of \$\mathbf{F}1,164,421.20.

TITLE - This Ordinance shall be entitled and known as "ORDINANCE PROGRAMMING THE AMOUNT OF ONE MILLION ONE HUNDRED SIXTY FOUR THOUSAND FOUR HUNDRED TWENTY ONE PESOS AND TWENTY CENTAVOS (\$1,164,421.20) A LUPMSUM APPROPRIATIONS EMBODIED UNDER IN SUPPLEMENTAL BUDGET BO. 2 CY 1997 AND SUPPLEMENTAL BUDGET NO. 1 CY 1998.
