PREFATORY STATEMENT

The Local Government Unit of Siayan, Zamboanga del Norte through
its Supplemental Budget preparation has lumpsum appropriations the
amount of P843,091.00 under Supplemental Budget No. 2, Calendar Year
1997 and the amount of P321,330.20 under Supplemental Budget No. 1 Ca-
lendar Year 1998 with a total amount of P1,164,421.20.

The Local Chief Executive passed an Executive Order No. 98-01
programming the amount of P1,164,421.20 into a priority projects needed
by the Municipal Government and for the welfare of the municipality of
Siayan, Province of Zamboanga del Norte.

To effect the implementation of the proposed projects, appropria-
tion ordinance is hereby acted by this body in support to the priority
projects approved by the Municipal Development Council.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan,
Zamboanga del Norte in session assembled:

SECTION I. TITLE - This Ordinance shall be entitled and known as
"ORDINANCE PROGRAMMING THE AMOUNT OF ONE MILLION ONE HUNDRED SIXTY FOUR
THOUSAND FOUR HUNDRED TWENTY ONE PESOS AND TWENTY CENTAVOS (P1,164,421.20)
A LUMP SUM APPROPRIATIONS EMBODIED UNDER IN SUPPLEMENTAL BUDGET NO. 2 CY
1997 AND SUPPLEMENTAL BUDGET NO. 1 CY 1998.

SECTION II. ORDAINING CLAUSE - that the amount of One Million One Hundred Sixty Four Thousand Four Hundred Twenty One Pesos and Twenty Centavos (P1,164,421.20) shall be program and appropriated into proposed projects, listed as follows:

- 1) Purchase of Mimeographing Machine P 40,000.00
- 2) Purchase of Sewing Machine/Handling 113,500.00
- 3) Stair Nosing 1,080.00
- 4) Improvement Existing HE Building 80,000.00
- 5) Construction/Maint./Improvement
of Barangay Roads 368,511.00
- 6) Construction of 2 Units HE Building 240,000.00
- 7) Construction of Barangay Roads 321,330.20


GRAND TOTAL = P1,164,421.00

SECTION III. EFFECTIVITY CLAUSE - that this Ordinance shall take effect on February 3, 1998.




