MUNICIPAL ORDINANCE NO. 004
Series of 1999

AN ORDINANCE REALIGNING THE AMOUNT OF FOUR THOUSAND FIVE HUNDRED (P4,500.00) PESOS FROM APPROPRIATIONS IN SALARIES IN THE MUNICIPAL HEALTH OFFICE FOR ADDITIONAL APPROPRIATIONS OF LAUNDRY ALLOWANCE IN THE SAME OFFICE.

Prefatory Statement

RA 7305 mandates among others the provision of P125 per month for laundry allowance of health workers. Its full implementation shall commence on January 1, 1999 however the LGU of Siayan has only provided P100.00 per month with an under-provision of P25.00/mo. the Municipal Health Office has a vacant item with funding of P184,920 per annum. Since the LGU is mandated and covered under provision of P25 per month per employer, thus this realignment.


In accordance with Sec. 336 of RA 7160 and by virtue of the power vested in the Sangguniang Bayan, be it ordained that


Sec. 1 - The amount of P4,500.00 be taken out from the appropriations of salaries in the office of the Municipal Health Office, and be added to the appropriations for laundry allowance in the same class of the same office.

Sec. 2 - The effectivity of the transfer is January 1, 1999 and disbursement thereof shall be subject to existing government accounting and auditing rules and regulations.


