

d) The resolution is in order.

The committee recommended that this proposed resolution be entered in the calendar of business for second reading. The committee's recommendations were adopted.

However said propose resolution was amended by Hon. Rudy S. Dominise during the final floor deliberation in second reading:

Hon. Dominise introduced amendments to make 600,000 pesos to 1.2 million since instead of two rooms it should make four rooms because that is national high school.

Hon. Felizardo I. Gayapa Sr. opposed to the amendments considering that this municipality and this body in particular and from the barangay governments of this town are requesting so many projects and they are over burdening the higher office so they will request little by little and perhaps by next year they will request another assistance.

The same time, Hon. Dominise inserted that if Barinaga provide 1.2 million pesos what is wrong and there is no harm. Anyway, that is national high school and he said that he experienced it in Gunyan. The enrollees and/or the class will move year by year to complete up to the 4th year and the student were dislocated where they conduct their classes.

In a related instance, Hon. Gayapa rebutted that the enrollees of Mangilay high school does not warrant for four classrooms since up to the present the 1st year and 2nd year is only more than 60.

Premise of the foregoing discussions and deliberations, the chair divide the house whether to approve the amendments introduced by Hon. Rudy S. Dominise to make 1.2 million pesos or remain the amount of 600,000.00 pesos proposed by the author Hon. Felizardo I. Gayapa Sr. .

Based on the result, the following were voted for the approval of the amendments:

Hon. Rudy S. Dominise, Hon. Oliver A. Atay Sr., Hon. Nilo T. Pollescas, Hon. Oliver A. Romero, and Hon. Tomas C. Labastida Sr.

Those who opposed were Hon. Felizardo I. Gayapa Sr., Hon. Daisy A. Limbang and Hon. Inocencio A. Limbang, while Hon. Nollie Anne V. Ponce and Hon. Elma S. Edias were abstained. Finally, said measure was considered and approved in second reading as amended.

The following measures quoted hereunder were considered and approved in the premise of second reading:

PREPATORY STATEMENT

The Municipal Treasurer and Municipal Accountant in a certification duly subscribed signified for the actual availability of the Monetized CY 2000 internal revenue allotment in the amount of P1,347,161.67 such amount is certified free of any obligations and whatever incumbrances thus available for supplemental appropriation.

BE IT ENACTED by the Sangguniang Bayan in session assembled:

SECTION I - That this appropriation ordinance shall be entitled An Ordinance making available the amount of One Million Three Hundred Sixty One Pesos and Sixty Seven Centavos (P1,347.161.67) for payment of various government operating expenditures of the Municipal Government of Siayan, ZN. as embodied in Supplemental Budget No. 2 CY 2002.

SECTION II - That there is cash actually available representing the monetized CY 2000 internal revenue allotment to cover various expenditures embodied in Supplemental Budget No. 2 CY 2002.

SECTION III - That LBP Form No. 161 and 152 are herewith appended to form part of the supplemental budget as authorized.

SECTION IV - That the supplemental budget No. 2 CY 2002 complied with the budgetary requirements and general limitations provided in the local government code, and made in accordance with the provisions of section 321 of the code.

SECTION V - That this Ordinance shall take effect upon its approval.
