PRELATORY STATEMENT

DILG Memorandum Circular No. 2006-42, dated May 4, 2006 directed all Local Government Units to establish/designate a "Freedom Parks" to be utilized in any public assemblies such as: rallies, demonstrations and other related activities within the municipality in pursuant to Section 15 of Batas Pambansa Blng. 880.

In compliance thereto, hence this enactment

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I TITLE: This shall be known as "AN ORDINANCE DECLARING/DESIGNATING THE AREA IN-BETWEEN ALUMBRE STREET AND BENLOT STREET AT THE BACK OF THE MUNICIPAL LIBRARY AS FREEDOM PARKS OF SIAYAN, ZAMBOANGA DEL NORTE."

SECTION II ORDANING CLAUSE. That the area in-between Alumbre Street and Benlot Street at the back of the Municipal Library building at Poblacon, this municipality is hereby declared/designated as "FREEDOM PARKS", Municipal map is hereto attached as form part of this ordinance.

SECTION III PENALTY CLAUSE. That any group of persons, organizations/associations and among others holding assemblies, rallies, demonstrations and other related activities out of the designated area in the municipality of Siayan, Zamboanga del Norte shall be penalized a fine of P500.00, an imprisonment of 30 days and/or in accordance with the penalty provided under Batas Pambansa Blng. 880.

SECTION IV. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon approval of the Sangguniang Pambansawigan of Zamboanga del Norte and posting of copies at conspicuous places and publication in official gazette.

RESOLUTION REQUESTING THE DISTRICT ENGINEER OF THE 1st ENGINEERING DISTRICT OF ZAMBOANGA DEL NORTE ATTENTION CHIEF MAINTENANCE ENGINEER FOR THE IMMEDIATE REPAIR/GRADING AND GRAVELLING OF SIAYAN-SINDANGAN ROAD TO SAVE FROM TOTAL DAMAGE AND DESTRUCTION.

WHEREAS, Siayan-Sindangan road with a length of 32.13 km was one of the roads identified and classified into secondary national road by the Department of Public Works and Highways year 2004;

WHEREAS, reclassification of road from provincial to national brings hopes and inspiration to the inhabitants of the concern Local Government Unit on the expectation that someday the long cherished dreams of the so called all weather roads may come true and be enjoyed by the continuing public along the perimeter of the two provinces of Zamboanga del Norte and Zamboanga del Sur.

WHEREAS, the present hopes for good roads to be delivered by the said department of the DPWH, was aborted into dismay and confusion since no proper maintenance had been initiated from the start of being secondary national road up to present

WHEREAS, the road sections from upper Demyan to Poblacon Siayan, from Poblacon to Gungay, thence to Lapuyan river where the boundary of the 1st Engineering District of Zamboanga del Norte ends, clamor to be taken care of, otherwise the act of abandonment of this road especially these rainy days, may cause to deteriorate its shape and canals and as a result will be no longer passable for vehicles, a condition contributory to economic dislocation;

WHEREFORE, premise of the foregoing consideration and on motion of Hon. Rudy S. Dominize, duly seconded by Hon. Oliver A. Romero, Hon. Felizardo I. Gayapa, Sr. and Hon. Samuel G. Baculpo, Sr., it was

RESOLVED, as this body hereby resolved to request the District Engineer of the 1st Engineering District of Zamboanga del Norte attention chief maintenance engineer for the immediate repair/grading and graveling Siayan-Sindangan road to save from total damage and destruction

RESOLVED FINALLY, to furnish copies of this resolution to the Regional Director, Department of Public Works and Highways (DPWH), Region IX, Zamboanga City for his information and appropriate action.

Carried unanimously."

WHEREAS, expenditures of the barangay are supposed to be obligated and liquidated in the same year they are incurred;

WHEREFORE, premise considered and on motion of Hon. Rudy S. Dominise, duly seconded by all members present, it was

RESOLVED, as this body hereby does to declare in order resolution No. 06 of Munica, however advised to strictly adhere to the existing local government accounting and auditing rules and procedures in its subsequent transactions.

RESOLVED FINALLY, to give copies of this resolution to all offices concerned for their information, reference and appropriate action.

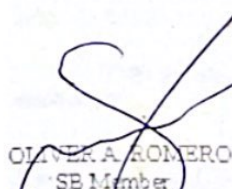

Since there being no further business before the Honorable Sangguniang Bayan in session assembled thus the Chair declared session adjourned at 5:00 O'clock in the afternoon.

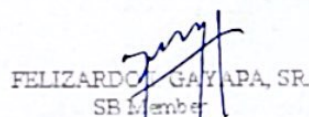
