"MUNICIPAL ORDINANCE NO. 07-04 Series of 2007

PREFATORY STATEMENT

AN ORDINANCE IMPOSING FEES AND/OR CHARGES OF FARM MACHINERY (TRACTOR) OPERATION/SERVICES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE IN THE AMOUNT OF P1,000.00 PESOS PER HECTARE PROVIDED HOWEVER ADDITIONAL CHARGES BE COLLECTED ON THE TRAVEL DISTANCE BETWEEN THE NUMBER OF HECTARES TO BE CULTIVATED. .

PREFATORY STATEMENT

The Local Government Unit of this municipality had acquired One (1) unit Farm Machinery (Tractor) TD90D New Holland Brand, aid from the Department of Agriculture (DA), Regional Field Unit (RFU)-IX under the Zamboanga Integrated Agricultural Development Program (ZIADP) thru the efforts of Hon. Congressman Roseller L. Barinaga and Hon. Governor Rolando E. Yebes.

Said farm machinery is for hire to all farmers in and outside the municipality of Siayan, apparently, to cover-up its wear and tear and other miscellaneous expenditures like crude oil, spare parts including the wages of operator and truck man hence this enactment.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE IMPOSING FEES AND/OR CHARGES OF FARM MACHINERY (TRACTOR) TD90D NEW HOLLAND OPERATION/SERVICES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE, IN THE AMOUNT OF P1,000.00 PESOS PER HECTARE PROVIDED HOWEVER ADDITIONAL CHARGES BE COLLECTED ON THE TRAVEL DISTANCE BETWEEN THE NUMBER OF HECTARES TO BE CULTIVATED.

SECTION II. ORDAINING CLAUSE. That the amount of One Thousand Pesos (P1,000.00) is hereby collected per hectare in the operation/services of farm machinery (Tractor TD90D New Holland Brand) provided however additional fees/charges shall be collected between the travel distance and number of hectares to be cultivated, viz:

Category A - 0-3 Km travel at least 1 Hectare Category B - 3.1 to 10 Km at least 3 Hectare Category C - 10.1 to 18 Km at least 5 Hectare Category D - 18.1 to 25 Km 7 Hectare Based on the above fractions/indications, there shall be collected additional charges in the amount of P37.80 per 3 kilometers if the number of hectares does not meet the required categorized travel distance. Provided further that the operation/services of the tractor shall be a minimum of One (1) hectare.

SECTION III. ADMINISTRATIVE PROVISIONS. That the fees and charges herein imposed shall be paid to the Municipal Treasurer's office and shall likewise issue an official receipt prior to its operation. That the collected fees and charges shall accrue to the General Fund. This Ordinance is form part of the Municipal Revenue Code of this municipality.

SECTION IV. EFFECTIVITY. This ordinance shall take effect 30 days after its approval and posting of copies at conspicuous places and publish in official gazette.
