"MUNICIPAL ORDINANCE NO. 11-04
Series of 2011

PREFATORY STATEMENT

One (1) of the Basic Services exercise by the local government unit as provided in RA 7160 Section 17, Par (v) is information services which include investments and job placements information systems, tax and marketing information systems and maintenance of public library.

The present administration initiated in other way a method of information by way of film showing wherein the people of Siayan may learn and acquire modern technologies and/or gain knowledge and skills from the different well-developed foreign countries at the same time as a mode of entertainment, thus a projector was acquired for the said purpose.

Essentially, in the delivery of the foregoing services it incurred various expenses particularly rentals of informative phonograph materials, electric power and maintenance of the wear and tear of the equipments hence fees and charges to be imposed upon use of these equipment is appropriate.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE IMPOSING FEES AND CHARGES ON FILM SHOWING OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE"

SECTION II. IMPOSITION OF FEES AND CHARGES. There shall be collected fees and charges in every film showing conducted in the following rates as general admission:

12 years old below	Php 10.00
12 years old above.....	Php 20.00
For Hire Showing (Section V).....	Php 1,500.00

SECTION III. SCHEDULE OF SHOWS. The local government unit through the Office of the Municipal General Services Office (MGSO) shall conduct film showing every Sunday at ABS Sports Complex and will start at 1:00 o'clock in the afternoon and one (1) film shall be played twice of the scheduled time.

SECTION IV. MOBILE FILM SHOWING. Film showing shall be extended anytime to the different barangays excluding Poblacion upon the request of the barangay officials concerned as part of their activity in any celebrations held particularly during Araw and Fiesta, provided however, the same fees and charges herein imposed shall be collected.

SECTION V. FOR HIRE SHOWING. Any person or group of persons, families, organizations/associations and the like can request or hire the Local Government Unit for film showing using the projector with wide screen, provided the corresponding fees and charges cited in Section II shall be paid accordingly.

SECTION VI. EXEMPTIONS. Collection of fees and charges is exempted during trainings/seminars, barangay visitation and information dissemination conducted by the Local Government Unit.


SECTION VII. SEPARABILITY CLAUSE. That this Ordinance shall form part of the Municipal Revenue Code.

SECTION VIII. EFFECTIVITY. This ordinance shall take effect upon approval of the Hon. Sangguniang Panlalawigan of Zamboanga del Norte and publication in a newspaper of general circulation in the province.


SECTION III. EFFECTIVITY. This ordinance shall take effect upon the approval of the Sangguniang Panlalawigan of Zamboanga del Norte.
