"APPROPRIATION ORDINANCE NO. 15-05 Series of 2015

PREFATORY STATEMENT

The Municipal Treasurer and Municipal Accountant had certified the availability of funds amounting to EIGHT MILLION EIGHT HUNDRED THIRTY SIX THOUSAND TWO PESOS AND TWENTY ONE CENTAVOS (PHP 8,836,002.21) sourced from Retained Earnings FY 2014 which is free of any encumbrances and subject for budgeting to cater the various expenditures of the local government unit of this municipality.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "APPROPRIATION ORDINANCE MAKING AVAILABLE THE AMOUNT OF EIGHT MILLION EIGHT HUNDRED THIRTY SIX THOUSAND TWO PESOS AND TWENTY ONE CENTAVOS (PHP 8,836,002.21) REPRESENTS RETAINED EARNINGS FY 2014 EMBODIED IN SUPPLEMENTAL BUDGET NO. 1 FY 2015 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE. That the amount of EIGHT MILLION EIGHT HUNDRED THIRTY SIX THOUSAND TWO PESOS AND TWENTY ONE CENTAVOS (PHP 8,836,002.21) is hereby made available for various expenditures of the local government unit. Statement of Funding Sources (LBP Form No. 9) and Statement of Supplemental Appropriation (LBP Form N0.10) is hereto attached as form part of this ordinance.

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval.

RESOLVED, as it is hereby resolved, to adopt the recommendation of the Committee on Finance and Appropriation, per Report No. FA-15-12, dated July 6, 2015, that Appropriation Ordinance No. 15-05, s. 2015 of the Sangguniang Bayan of Siayan, this province, making available the amount of Eight Million Eight Hundred Thirty Six Thousand Two Pesos and Twenty One Centavos (P8,836,002.21) represents retained earnings FY 2014 embodied in Supplemental Budget No. 1 FY 2015, for various expenditures of said local government unit, be declared in order and operative, for having substantially complied with the pertinent provisions of Section 321, R.A. 7160 provided, however that the grant of clothing allowance shall be within the PS cost limit.
