MUNICIPAL ORDINANCE NO. 98-05

AN ORDINANCE REVISING THE INTERNAL RULES OF PROCEDURES OF THE SANGGUNIAN BAYAN OF SIAYAN, ZAMBOANGA DEL NORTE EMBODIED UNDER MUNICIPAL ORDINANCE NO. 004, SERIES OF 1995, CHAPTER III, OTHERWISE KNOWN AS THE CODE OF GENERAL ORDINANCES.

BE IT ORDAINED by the Honorable Sanggunian Bayan of Siayan, Zamboanga del Norte in session assembled:

RULE I

Section I-1. This Ordinance shall be entitled and be known as INTERNAL RULES OF PROCEDURES of the Sanggunian Bayan of Siayan, Zamboanga del Norte.

RULE II



Section II-2. The Legislative Body Composition, Election of Officer, creation of standing committees, with its corresponding Chairman and members thereof, and their duties and responsibilities.

(a) The legislative body of the local government unit shall be known as the Sanggunian Bayan.

(b) The Sanggunian Bayan is composed of the Municipal Vice Mayor, the eight (8) regular members of the Sanggunian Bayan who are elected at large, the President of the Association of Barangay Councils, the Municipal Federation of the Sanggunian Kabataan, and the three (3) representatives, (1) one from women, One (1) from agricultural workers, and one (1) from indigenous cultural communities.

(c) Officers with its duties, rights and obligations: There shall be and officers elected in the Sanggunian Bayan other than the Municipal Vice Mayor as the Presiding Officer, on the first regular session after assumption into office of the newly elected Sanggunian Bayan, viz:

1. Presiding Officer Pro-Tempore
2. Floor Leader



Section XXVI -88, Amendments how Made. Any amendments to these Rules shall be presented in writing and include in the agenda shall be approved by the majority vote of all the members of the Sangguniang Bayan. No amendment shall be presented within three (3) months after approval of these rules or after the last amendments.

RULE XXVII - Miscellaneous Provision

Section XXVII -89 Committee Hearing shall be in formal attire/in prescribed uniform.

Section XXVIII Applicability Clause

Section XXVIII -91 Applicability of other Issuances. The rules and regulations implementing the local government code and other issuances of national government agencies pertaining to legislative are hereby made an integral part of this ordinance.

RULE XXIX - ^Repealing Clause

Section XXIX -92 All ordinances, Resolutions, ^Rules and ^Regulations or part thereof, in conflict or inconsistent with the provisions of this ordinance are hereby repealed and or modified accordingly.

RULE XXX - Penalty Clause


Section XXX -93 Penalty. Any Sangguniang Bayan Member who violates any provision under this ordinance shall be and subject to penalty of not more than FIVE HUNDRED (P500.00) pesos at the discretion of the Honorable Court.

RULE XXXI - EFFECTIVITY CLAUSE


Section XXXI -94. That this Ordinance shall take effect 30 days after approval and publication of copies by furnishing to all concerned.
