"MUNICIPAL ORDINANCE NO. 00-205 Series of 2000

AN ORDINANCE NAMING THE UNIDENTIFIED MUNICIPAL STREETS AT POBLACION, SIAYAN, ZAMBOANGA DEL NORTE IN HONOR OF THE PAST LOCAL OFFICIALS IN PURSUANT TO THE AUTHORITY FROM THE NATIONAL HISTORICAL INSTITUTE.

PREFATORY STATEMENT

WHEREAS, municipality of Siayan was created by virtue of Republic Act 4989 in 1967. Some civic spirited personalities once became the pioneer local officials and in addition to, shared a portion of their real properties by way of donations for the municipal government lots and school sites; viz:

- 1. Late Catalino C. Sabaricos, Barangay Captain (1960-1965)
 Municipal Vice Mayor (1968-1980) and denor of municipal lot.
- 2. Late Calilang Sibuco, Donor of Municipal Lot.
- 3. Late Maximino C. Escuadro, Sangguniang Bayan (1968-1985)
- 4. Late Feliciano E. Castillo, Barangay Captain (1968-1972) Sangguniang Bayan (1972-1986) and donor of lot for Siayan National High School.
- Late Santos A. Calumpang, Barangay Councilman (1968-1972)
 Barangay Captain (1972-1982) and donor of Municipal Lot.

WHEREAS, indicating municipal streets into their names may serves as memento for their valuable services rendered with love, affection and generousity to the people of this municipality;

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte:

SECTION I. TITLE: This Ordinance shall be entitled "AN ORDINANCE NAMING THE UNIDENTIFIED MUNICIPAL STREETS OF POBLACION, SIAYAN, ZAMBOANGA DEL NORTE IN HONOR TO THE PAST LOCAL OFFICIALS AND DONORS OF MUNICIPAL LOTS:"

SECTION II. ORDAINING CLAUSE - that the unnamed Municipal Streets as indicated in the road network hereto attached, marked as Annex "A" and automatically become a part of this ordinance using the color coding shall be named as follows:

a) RED - from the junction of Provincial Road or National Highway to Rizal Street be Named CATALINO C. SABARICOS Street.



- YELLOW from Sabaricos Street to Rizal Street shall be named CALILANG SIBUCO STREET.
- c) BROWN from the junction of Quirino St. to piao river shall be named MAXIMINO C. EXCUADRO STREET.
- d) BLUE from Osmena Street to Roxas Street thence to Subdivision shall be named FELICIANO E. CASTILLO STREET.
- e) GREEN from Roxas Street to sub-division shall be named SANTOS AND REMEDIOS C. CALUMPANG STREET.

SECTION III. REPEALING CLAUSE: that Municipal Ordinance Nos. CO1 and CO2, Series of 1999, and other rules and regulations inconsistent herewith or inconflict any of the provisions of this ordinance are hereby amended, repealed and modified accordingly.

SECTION IV. EFFECTIVITY CLAUSE: that this ordinance shall take effect Thirty (30) days after approval and publication of copies by posting at conspicuous places and furnished to all concerned.
