The regular session was called to order by the Hon. Presiding Officer Municipal Vice Mayor Ephraim O. Melindo at 8:00 O'clock in the morning. It was opened with a prayer led by Hon. Inocencio A. Limbang.

Then the chair declared quorum after calling the roll, since majority of the Sangguniang Bayan members were present.

The reading of the minutes of the previous regular session was dispensed, and the same were stand approved as dispensed with, considering that each member had provided a copy, moved by Hon. Felizardo I. Gayapa, Sr., duly seconded by Hon. Samuel G. Baculpo, Sr. and Hon. Daisy A. Limbang.

The same time, Hon. Inocencio A. Limbang moved for the approval of the Calendar of Business embodied in the order of business, duly seconded by Hon. Estrella S. Zapatos.

Since no one took the privilege hour, thus proceeded to the business for first reading of the different measures entered in the reference of business therefore referred and assigned to concerned committees for study, however some items were moved to be treated as urgent after the rules in the order of business was suspended temporarily by Hon. Rudy S. Dominise and Hon. Felizardo I. Gayapa, Sr., stated hereunder:

1. PROPOSED ORDINANCE MAKING AVAILABLE THE AMOUNT OF P1,033,199.36 TO COVER EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE AS EMBODIED IN SUPPLEMENTAL BUDGET NO. 01 CY 2006.
2. PROPOSED RESOLUTION AUTHORIZING THE CONSTRUCTION OF PANGASE BOOTH SOURCED FROM THE MIF OF THE SANGGUNIANG BAYAN AMOUNTING TO P30,000.00 AT THE BACK OF THE MUNICIPAL LIBRARY, POBLACION, SIAYAN, ZN. (Sponsored by: HON. FELIZARDO I. GAYAPA, SR.)
3. PROPOSED RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS & HIGHWAYS (DPWH) DIPOLOG CITY TO CONSTRUCT A DETOUR ROAD TRAVERSING CALACAS CREEK. (Sponsored by: HON. FELIZARDO I. GAYAPA, SR.)
4. PROPOSED RESOLUTION RESTRICTING ALL CARGO TRUCKS NOT TO PASS THE BRIDGE ALONG SINDANGAN-SIAYAN ROAD CARRYING BEYOND THE CAPACITY LIMIT OF THE BRIDGE. (Sponsored by: HON. FELIZARDO I. GAYAPA, SR.)

Consequently, after due deliberations, the four (4) measures treated as urgent were considered and approved, quoted hereunder:

PREFATORY STATEMENT

The Finance Committee has certified to the availability of funds in the amount of P1,033,199.36 retained earnings of the previous years, free of any encumbrances or obligations whatsoever which is subject for appropriation to defray various expenditures in the operation of the local government unit of this municipality, hence this ordinance.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "An Appropriation Ordinance Making Available the Amount of ONE MILLION THIRTY THREE THOUSAND ONE HUNDRED NINETY NINE THIRTY SIX CENTAVOS (Php 1,033,199.36) Embodied in Supplemental Budget No. 1 CY 2006 for Various Expenditures of the Local Government Unit".

SECTION II. ORDAINING CLAUSE: That the amount of P1,033,199.36 embodied in Supplemental Budget No. 1 CY 2006 is hereby made available to defray the following expenditures:

SECTION III. EFFECTIVITY. That this ordinance shall take effect upon approval of the Sangguniang Panlalawigan of Zamboanga del Norte.

WHEREFORE, premise considered and on motion of Hon. Felizardo I. Gayapa, Sr., duly seconded by Hon. Liberato P. Nalzero, Hon. Estrella S. Zapatos and Hon. Samuel G. Baculpo, Sr., it was

RESOLVED, as this body hereby resolved to authorize the construction of house/booth with appropriation sourced from the MIF of the Sangguniang Bayan Members in the amount of P30,000.00 to be constructed at the back of the municipal library.


Since there being no further business before the Honorable Sangguniang Bayan in session assembled thus the Chair declared session adjourned at 5:00 O'clock in the afternoon.


