"MUNICIPAL ORDINANCE NO.11-05 Series of 2011

PREFATORY STATEMENT

WHEREAS, the 1996 implementing rules and regulations of Republic Act No. 8172 known as ASIN Law, was revised to conform with developments to strengthen and fast track implementation of the law and ensure that only iodized salt for human and animal consumption is available in the country.

WHEREAS, the same law under Rule VI, Section 2, mandated the local government units to support the development and sustainability of Salt Iodization Program in coordination with the DILG particularly the enactment and enforcement of ordinances for the implementation of the ASIN LAW by requiring all outlets, supermarkets, wet markets and vendors to sell only iodized salt and food service establishments such as restaurants to use iodized salt and to display in their premises the proper signage that they used iodized salt for all their food products.

WHEREAS, the regular use of lodized Salt is expected to alleviate the lodine Deficiency Disorder suffered by several residents in the Municipality especially those living in the far flung barangays.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE REQUIRING ALL SARI-SARI STORE OWNERS, FOOD ESTABLISHMENTS SUCH AS RESTAURANTS, CARENDERIA AND THE LIKE IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE TO SELL/RETAIL/UTILIZE IODIZED SALT AND PENALIZING ANY VIOLATION THEREOF".

SECTION II. DEFINITION OF TERMS

 lodized Salt – Ordinary salt fortified with Potassium lodate (k103) or other sullable fortificant approved by DOH-BFAD.

 Micronutrient Malnutrition – refers to a disorder resulting from deficiencies in vitamin A, Iron, Iodine, and other micronutrients which the body needs in ni nute quantities every day.

Iodine Deficiency Disorder – a broad spectrum of manifestation resulting from lack
of lodine in the diet which leads to the restriction of intellectual and physical callacity
affecting everyone who is lodine deficient and may manifest as goiter, mental
retardation, physical and mental defects and cretinism.

- Food Service Establishment refers to hotels, restaurants, cafeteria, catering firms, hospitals, canteens including food vendors and other outlets which serve or sell food to customers.
- Retail Outlets refers to person or establishment who sells salt to customers which includes groceries, sari-sari stores, wet market stall and hawkers.
- Label any written, printed or graphic matter upon any article or any of its container or wrapping or accompanying the packaged food, that describes the product.

SECTION III. ADMINISTRATIVE PROVISION. All retail outlets are hereby required to sell only iodize salt and properly labeled and the Food Service Establishment shall utilize iodize salt only in preparing and/or cooking their foods.

In the enforcement of this ordinance all aforesaid establishments shall be monitored/inspected once in every month by the monitoring team. The monitoring team shall maintain list of all retail outlets, food establishments and among others with the corresponding name of the proprietor and its location.

SECTION IV. COMPOSITION OF MONITORING TEAM. The Municipal Mayor shall constitute the monitoring team to conduct regular inspection to all concerned establishments from the following offices:

- 1. Market Inspection
- 2. Municipal Health Office
- 3. Sanitary Inspection
- 4. Other personnel(s) designated by the Chief Executive.

SECTION V. ADMINISTRATIVE SANCTION. Any violation of this Ordinance FOR T-IE SECOND TIME SHALL AUTHORIZE THE Municipal Mayor to revoke the business permit of the offending establishment.

SECTION VI. PENALTY CLAUSE. Any violation of this ordinance shall be penalized a fine in the amount of Five Hundred Pesos (PhP500.00) and an imprisonment of Thirty (30) days but not more than Sixty (60) days or both fine and imprisonment upon the discretion of the Honorable Court.

SECTION VII. EFFECTIVITY. This ordinance shall take effect 30 days from the approval of the Honorable Sangguniang Panlalawigan of Zamboanga del Norte and publication in Newspaper of general circulation in the province.
