PREPATORY STATEMENT

The Municipality of Siayan is a beneficiary of the ARCP2 of the Department of Agrarian Reform

BE IT ORDAINED therefore by the Sangguniang Bayan in session assembled:

SECTION I – TITLE: That this Ordinance shall be entitled "AN APPROPRIATION ORDINANCE
APPROPRIATING THE AMOUNT OF P8,381,740.00 AS PARTIAL COUNTERPART FUNDS FOR THE
P86,363,588.16 ROAD PROJECTS UNDER ARCP2 OF THE DEPARTMENT OF AGRARIAN REFORM
(DAR)".

SECTION II – FUNDING ALLOCATION: That already existing as Continuing Appropriation is the
amount of P7,381,740.00 and aide from Congressional Fund in the amount of P 1,000,000.00 shall form
part as partial counterpart funds for these above-enumerated FMRs;


That additional appropriations of the remaining obligations shall be provided by the Supplemental

SECTION III. AUTHORITY TO TRANSFER FUNDS: That the Municipal Treasurer is hereby authorized to transfer the amount of EIGHT MILLION THREE HUNDRED EIGHTY ONE THOUSAND SEVEN HUNDRED FORTY PESOS (P 8,381,740.00) from general fund to trust fund as LGU counterpart for Farm to Market Road Projects under ARCP 2 of DAR.

SECTION V- EFFECTIVITY: That this Ordinance shall take effect immediately.


