MUNICIPAL ORDINANCE NO. 99-06 Series of 1999

AN ORDINANCE PROHIBITING LARGE CATTLE OWNERS/RIDERS COMING TO POBLACION, SIAYAN, ZN. RIDIEG/DRAWNING THEIR ANIMALS TO APASS ALONG THE MUNICIPAL STREETS AND CONCRETE PAVEMENT UNLESS THEY BRING ALONG WITH THEM A POUCH, PALE AND THE LIKE FOR EXCRETA OF THEIR ANIMALS.

Prefatory Statement

Most households/residents in the municipality of Siayan ewned working animals like carabaes, cows and horses which at the same time use them as carriers, draw carts/sledge when they come to Poblacian for any demostic purpose.

Poblacien streets are mostly comented and properly maintained for its cleanliness by the Local Government Unit, however, excreta and wastes of animals semetimes could not be prevented.

Excreta or wastes of these animals are unsanitary and considered sere eyes to the resident of Poblacion, particularly to our tooming visitors now-adays and seem.

BE IT ORDAINED by the Henorable Sangguniang Bayan of Siayan, Zamboanga del Norte in session assembled;

SECTION I. TITLE. This ordinance shall be known as "An Ordinance Prohibiting large cattle/riders/owners bringing their animals to pass along the municipal street concrete pavement unless they bring along with them a pouch pale or any kind for the excreta of their animals.

SECTION II. DECLARATION OF POLICY: To maintain the cleanliness of the municipal streets concrete pavement at Poblacion, Siayan, ZN. all large cattle evnera/riders bringing their animals to Poblacion are prehibited to pass along the concrete pavement unless they bring along a pouch, pale and the like for the excreta of their animals.

SECTION III. REGULATED ACT:

a) Owners/riders bringing their carabao, cows and horses coming to the Poblacion who fail to bring pouch, pale and and the like for exercise of their animals shall keep/tie their animals within the premises prior to the approach of concrete pavement provided not hazardous to transportation and shall always seek permission of the landowner where their animals shall be tied.

b) Owners/riders, bringing their carabao, cows and horses to Poblacion with pouch, pale and the like, therefore are authorized to pass along concrete pavements, likewise in the case that their animals will remove their exerte, the owner/riders shall properly dispose-of using the pouch, pale and the like.

SECTION IV. PENALTI CLAUSE: Any person group of person, owners and riders who violated this ordinance shall be penalized a fire of, 1st offense warning 2nd offense 200.00, 3rd offense \$500.00 but not more than \$700.00 and imprisonment of 5 days but not more than 10 days or both fines and imprisonment upon the descretion of the court.

SECTION V. EFFECTIVITY CLAUSE. This ordinance shall take effect 30 days after approval, public hearing and posting/publication of copies to conspicuous places.
