MUNICIPAL ORDINANCE NO. 00-06

ORDINANCE CREATING THE POSITION OF MAINTENANCE CONSTRUCTION FOREMAN, SALARY GRADE 8 IN THE ORGANIZATIONAL CHART AND STAFFING PATTERN OF THE MUNICIPAL GOVERNMENT OF SIAYAN, ZAMBOANGA DEL NORTE AND INCLUDING THE SAME IN THE PLANTILLA OF PERSONNEL FOR CY 2000.

PREFATORY STATEMENT

Engineering works have been massively undertaken in the locality be they horizontal or vertical. Laborers are hired in job order and contractual basis where supervision must come from a regular employee who may be appointed base on the civil service laws and regulations.

A foreman to do the job is required however the position is not included in the organizational chart and staffing pattern of the local government unit of this municipality, thus it is hereby created.

BE IT ORDAINED, by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: This ordinance shall be known "An Ordinance Creating the Position of Maintenance Construction Foreman - Salary Grade 8" in the organizational chart and staffing pattern of the municipal government of Siayan and including the same in the plantilla of personnel CY 2000.



SECTION III. EFFECTIVITY: This ordinance shall take effect upon its approval.




