EXPLANATORY STATEMENT

The Local Finance Committee of the municipal government of Siayan, Zamboanga del Norte certified the probability of collecting the amount of P41,296,822.00 for the year 2003. After looking and deliberating on the report of the Committee on Appropriations, Ways and means, the Executive Budget submitted for authorization was found to be consistent with the approved local development plans and such other existing guidelines and parameters on budgeting. The budget has adequately provided funds for the delivery of basic services and maintenance of facilities as provided in sec. 17 (b) of RA 7160. Statutory and mandatory obligations have been provided and economy measures have been put in place with the retention of 25% in the utilization of maintenance and other operating expenditures appropriations.
