#### PREFATORY STATEMENT

Article F, Chapter V of Ordinance No. 00-002, Series of 2000, known as the Municipal Revenue Code of Siayan, Zamboanga del Norte is imposing fees, charges or rentals of equipments, tools, buildings, vehicles and other municipal government facilities.

The fees, charges and rentals imposed are very minimal that can no longer meet the present cost of spare parts, construction materials and other commodities on its wear and tear as time of operation goes on. The previous rates need to be revised and be updated in order to response the need of time due to the continous increase of prices of all commodities for its maintenance and etc.

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE AMENDING ARTICLE F CHAPTER, CHAPTER V PER ORDINANCE NO. 00-002 KNOWN AS THE MUNICIPAL REVENUE CODE OF SIAYAN, ZAMBOANGA DEL NORTE".
