**"MUNICIPAL ORDINANCE NO. 15-06
Series of 2015**

PREFATORY STATEMENT

The Office of the Senior Citizen's Affairs (OSCA) is the concerned agency that responsible to undertake and implement the government's goal, plans and programs for the welfare of the senior citizens. It includes their economic security and affordable comprehensive health care. Said office also works to improve attitudes about the elderly in the workplace and conducts research about the needs and problems of an aging population.

The schedule for the different activities of the Senior Citizens herein imposed in the municipality of Siayan is part of their medical care or Medicaid, and exposure to the community wherein these elderly persons can feel that they are given priority importance by the government and at all times have an important role in local governance for the welfare and development of the community.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE ESTABLISHING THE MONTHLY ACTIVITIES AND SCHEDULE OF TIME AND DAY OF THE SENIOR CITIZENS AT THE DIFFERENT BARANGAYS OF SIAYAN, ZAMBOANGA DEL NORTE.

SECTION II. ACTIVITIES AND SCHEDULE OF TIME AND DAY: It is hereby established the activities and schedule of time and day of the Senior Citizens at the different barangays in the municipality of Siayan, Zamboanga del Norte:

SECTION III. ADMINISTRATIVE PROVISION: The Municipal Health Services through the respective Midwives assigned in the barangay shall be liable for the Regular Monthly Check-up of the Blood Pressure and weighing of all the Senior Citizens who are resident or non-resident that present during the conduct of the above-scheduled activities. The Municipal Health Officer (MHO) and other health personnel are entitle to assist the midwife upon receiving the official directives from the Local Chief Executive.

The President of the Association of the Senior Citizens in the respective barangays shall be liable for the conduct of social gatherings, programs and socialization of the above-stated schedule. The Chairman of the Office of the Senior Citizen's Affair (OSCA) will regularly visits and observed in the conduct of the above-cited activities.

SECTION IV. EFFECTIVITY. This ordinance shall take effect upon approval.
