> MUNICIPAL ORDINANCE NO. 98-07 Series of 1998

AN ORDINANCE REGULATING THE OPERATION OF SING-A-LONG THROUGH VIDEO KARAOKE AND THE LIKE ESTABLISHED WITHIN THE PUBLIC MARKET OF SIAYAN, ZAMEOANGA DEL NORTE.

BE IT ORDAINED by the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte is session assembled:

## PREFATORY STATEMENT

In big cities, Sing-a-long through video karaoke and similar establishments like disco houses, live concert, band and other business which accompanied with musical instruments/needs a sound proof building/ hall to avoid disturbance to the public.

Compared to the small town of Siayan, sound proof of the aforecited establishments could not be realized considering that the operators are occupying in the government shall within the public market, thus only time and the volume of sound is hereby regulated as a rule.

SECTION I. TITLE - That this ordinance shall be entitled as "ORDINANCE REGULATING THE OPERATION OF SING-A-LONG THROUGH VIDEO KARAOKE AND THE LIKE WITHIN THE PUBLIC MARKET OF SIAYAN, ZAMBOANGA DEL NORTE."

SECTION II. REGULATED ACTS - That the sing-a-long thru video karaoke and the like is hereby regulated as a rule, as follows:

- a) TIME LIMIT That the sing-a-long through vides karaoke and the like will open started from 6:00 AM and will end at 12:00 o'clock midnight.
- b) LIMITED VOLUME Taket started at 10:00 o'clock PM up to 12:00 o'clock midnight the volume or loudness of the instruments/vocals will be minimize that will not covered approximately seventy (70) meters circumference.

SECTION III. <u>PENAL CLAUSE</u> - Any operators who violates this ordinances shall suffer a fine of not less than \$500.00 but not more than \$1,000.00 or an imprisonment of 5 days but not more than 10 days or both fines and imprisonment in the discretion of the court.

SECTION IV. EFFECTIVITY - That this ordinance shall take effect thirty (30) days after approval publication of copies to conspicous places;
