### MUNICIPAL ORDINANCE NO. 00-07 Series of 2000

AN ORDINANCE DIRECTING ALL PEDDLERS/DEALERS/IMPORTERS AND THE LIKE TO SECURE PERMIT FROM THE MUNICIPAL MAYOR OR HIS DULY AUTHORIZED REPRESENTATIVE AND THEREFROM SECURE CLEARANCE FROM SIAYAN PNP PRIOR TO ENGAGE BUSINESS TRANSACTIONS IN SIAYAN, ZAMBOANGA DEL NORTE.

### PREFATORY STATEMENT

It has been observed that unidentified peddlers/dealers/importers and the like come to Siayan bringing assorted goods and merchandise with or without service vehicles to engage in business directly to their patrons without seeking permit/clearance and even meet with the Local Chief Executive and the Chief of Police as a matter of identification and compliance with any business requirements.

Presently nationwide, the people are now walking under the shadow of treat, fear or extreme fright or dread due to violence and terrorism committed by Abusayaf, MILF, CPP-NPA and other suversives.

This ordinance is hereby formulated to pre-empt any terroristic activities in Siayan as one of the security measures.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: This ordinance shall be known as "An Ordinance Directing all Peddlers/Dealers/Importers of any goods and merchandise and the like to secure permit from the Municipal Mayor or his duly authorized representative and therefrom secure clearance from Siayan PNP prior to engage business transactions in Siayan, Zamboanga del Norte."

SECTION II. ORDAINING CLAUSE: All peddlers, dealers, importers and the like coming to Siayan are hereby directed to:

- 4) Secure permit/Clearance from the Municipal Mayor and/or to his duly authorized representative and from the Siayan PNP prior to engage business transactions in this town.
- b) All peddlers/dealers/importers and the like are directed to present, show and identify their goods and merchandise with the presence of any police authority or law enforcers prior to actual selling for security reasons.

c) All peddlers/dealers/importers and the like shall kept in his position a permit/clearance or any documents issued by the Municipal Mayor and or the Police of this municipality ready at any time for inspection.

SECTION III. PENAL PROVISION: Any peddlers, dealers, importers and the like found to be violating this ordinance shall be penalized a fine in the amount of \$300.00 pesos but not more than \$700.00 pesos and imprisonment of 15 days but not more than 30 days and or both fines and imprisonment upon the discretion of the Honorable Court.

SECTION IV. EFFECTIVITY CLAUSE: This Ordinance shall take effedt 30 days after its approval.
