Consequently, after due deliberations, the aboved measure treated as urgent was considered and approved, quoted hereunder:

## "MUNICIPAL ORDINANCE NO. 06-07 Series of 2006

#### PREFATORY STATEMENT

As provided by law, under Chapter I, Section 440 of RA 7160, known as the Local Government Code of 1991, it is the role of the local government unit to ensure the delivery of basic services and effective governance for the general welfare of the inhabitants within its territorial jurisdiction.

Along these services includes health services enumerated under Section 17 par (2) sub par (iii) and information services explicitly mentioned under Section 17 par (2) sub par (v).

Just recently, the municipality of Sisyan established community center under the program of the office of the President thru the Commission on Information and Communication Technology and National Computer Center, Diliman, Quezon City, which gives the community access to information and community technology services.

In the delivery of such services, the local government unit incurred various expenses to sustain/continuous its operation, hence this ordinance imposing fees and charges to partially generates income and/or revenue resources to recover and/or return of the invested capital as authorized under section 129 of RA 7160.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE IMPOSING FEES AND CHARGES OF VARIOUS BASIC SERVICES RENDERED BY THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE".

SECTION II. ORDAINING CLAUSE: There shall be collected fees and charges of the following services rendered by the local government unit, of this municipality:
