"MUNICIPAL ORDINANCE NO. 07-07
Series of 2007

PREFATORY STATEMENT

The Department of Budget and Management (DBM) issued Local Budget Circular No. 84 dated April 13, 2007 providing for the revise rate of Representation and Transportation Allowance (RATA) for the Local officials when funds are available of the Local Government Unit concerned.

To implement such circular, the Annual Budget CY 2007 of the Local Government Unit of this municipality duly approved by the Sangguniang Panlalawigan has an existing appropriation of other personnel benefits intended for subsequent issuances for such purpose and the amount required is P357,660.00 that may be culled out from said appropriation.

BE IT ORDAINED by the Sangguniang Bayan in session assembled:

SECTION I – TITLE. That this Ordinance shall be entitled "AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED FIFTY SEVEN THOUSAND SIX HUNDRED SIXTY (P357,660.00) PESOS FOR RATA DIFFERENCE OF MUNICIPAL OFFICIALS PER LBC 84 DATED APRIL 13, 2007 CHARGEABLE AGAINST THE APPROPRIATION OF OTHER PERSONNEL BENEFITS (1011-100-749) UNDER ANNUAL BUDGET CY 2007".

SECTION II – ORDAINING CLAUSE. That the amount of Three Hundred Fifty Seven Thousand Six Hundred Sixty (P357,660.00) Pesos shall be culled out from item 100-749 to augment appropriation of item 100-713 and 100-714 to implement LBC 84.


SECTION III – ADMINISTRATIVE PROVISION. That the Municipal Accountant, Municipal Budget Officer and Municipal Treasurer shall make the necessary adjustment in the book of records in compliance with this ordinance.


SECTION IV – EFFECTIVITY CLAUSE. That this ordinance shall take effect upon its approval.


