"MUNICIPAL ORDINANCE NO. 13-07 Series of 2013

PREFATORY STATEMENT

WHEREAS, the Sangguniang Bayan of this municipality had acted Municipal Ordinance No. 11-13, Series of 2011, dated November 24, 2011 entitled, "AN ORDINANCE GRANTING AUTHORITY TO THE HONORABLE MUNICIPAL MAYOR FLORA L. VILLAROSA TO EXERCISE THE POWER OF EMINENT DOMAIN OVER A PORTION OF PRIVATE LAND UNDER LOT NO. 2538-D-4P-1 OWNED BY LATE RAFAELA LANTICSE LOCATED AT UPPER RIVERSIDE, POBLACION, SIAYAN, RAFAELA LANTICSE LOCATED AT UPPER RIVERSIDE, POBLACION, SIAYAN, RAFAELA LANTICSE LOCATED AT UPPER RIVERSIDE, POBLACION, SIAYAN, PURPOSES.

WHEREAS, said Ordinance was submitted to the Hon. Sangguniang Panlalawigan in the Province of Zamboanga del Norte for review and appropriate action, however, it was returned without favorable action under SP Resolution No. 176, dated March 4, 2013, with advice to "re-pass the same stating therein compliance with the provisions of action 16 and 56 of RA 7160 and other specific requirements of law. Further advice Section 16 and 56 of RA 7160 and other specific requirements of law. Further advice that "it be expressly provided therein that the Municipal Mayor is authorized to represent the Municipality of Siayan, Zamboanga del Norte in the expropriation proceedings.

WHEREAS, it is provided under Section 16 of RA 7160 that every local government unit shall exercise the powers expressly granted, those necessary implied therefrom, as well as powers necessary, appropriate or incidental of its efficient and effective governance, and those which are essential to the promotion of the general welfare.

WHEREAS, the same law (RA 7160) under Section 19 provided that a local government unit through its Chief Executive pursuant to an ordinance, exercise the power of eminent domain for public use.

In compliance with the advice of the Hon. Sangguniang Panlalawigan abovestated, hence this enactment as **AMENDED**. BE IT ORDAINED, by the Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE GRANTING AUTHORITY TO THE HONORABLE MUNICIPAL MAYOR FLORA L. VILLAROSA REPRESENTING THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE TO EXERCISE THE POWER OF EMINENT DOMAIN OVER A PORTION OF PRIVATE LAND UNDER LOT NO. 2538-D-4P-1 OWNED BY LATE RAFAELA LANTICSE LOCATED AT UPPER RIVERSIDE, POBLACION, SIAYAN, ZAMBOANGA DEL NORTE APPROXIMATELY 307.2 SQUARE METERS FOR ROAD PURPOSES IN COMPLIANCE WITH THE PROVISIONS OF SECTION 16 & 19 of RA 7160.

SECTION II. AUTHORITY TO EXPROPRIATE: Authority is hereby granted to the Hon. Municipal Mayor Flora L. Villarosa representing the Municipality of Siayan, Zamboanga del Norte to initiate the expropriation proceedings over a portion of private land, under Lot No. 2538-D-4P-1, owned by the late Rafaela Lanticse located at Upper Riverside, Poblacion, Siayan, Zamboanga del Norte approximately 307.2 square meters for road purposes in compliance with the provisions with Section 16 and 19 of RA 7160 known as the Local Government Code of 1991.

SECTION III. REPEALING CLAUSE: Municipal Ordinance No. 11-13, Series of 2011 is hereby repealed.

SECTION IV. EFFECTIVITY: This Ordinance shall take effect upon approval and posting of copies at the conspicuous places and be forwarded to the Hon. Sangguniang Panlalwigan in the Province of Zamboanga del Norte in compliance with the provision of Section 56 of RA 7160.
