#### PREFATORY STATEMENT

The Local Government Unit of this municipality after the closing of the Book of Accounts CY 2007 had accumulated the amount P 4,144,862.65 continuing appropriations and retain earnings amounting to P 1,297,837.75 a total of P5,442,699.80;

The continuing appropriations above-mentioned has been reverted into unappropriated balance per Municipal Ordinance No. 08-03, Series of 2008, therefore in its utilization shall be authorized by the passage of Supplemental Budget hence this enactment;

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF Php 5,442,699.80 EMBODIED IN SUPPLEMENTAL BUDGET NO. 01, SERIES OF 2008 FOR VARIOUS EXPENDITURES OF THE LOCAL GOVERNMENT UNIT OF THIS MUNICIPALITY;

SECTION II. ORDAINING CLAUSE. That the amount of Php 5,442,699.80 is hereby made available for expenditures, provided however funds are available and in conformance to the usual accounting and auditing rules and procedures.

EFFECTIVITY CLAUSE. That this ordinance shall take effect upon approval of the Hon. Sangguniang Panlalawigan of Zamboanga del Norte..
