PREFATORY STATEMENT

Form the existence of the postal services in this municipality previously owned and controlled by the Philippine government, its office was established inside in the center part of the municipal hall and remained up to this present even it is now a private firm, however, the afore-cited office occupied by the post is now dilapidated which is due for renovation hence forced to vacate and was transferred and merged with the office of the TELECOM.

Just recently, the postal services main office has a policy of disqualifying a certain municipality to be established a post office which is deemed low income and unfortunately Siayan is now an extension office from the municipality of Sindangan in which will be opened only in every Tuesday and Thursday every week, thus the present administration thru Hon. Municipal Mayor decided to utilized such room for Community Electronic Center (Internet) of the local government unit.

Considering that the post office is listed as accountability of the Local Government Unit, hence this authority for its demolition for renovation purposes in conformance with the accounting and auditing rules and procedures.

BE IT ORDAINED by the Honorable Sangguniang Bayan in session assembled:

SECTION I. TITLE: This shall be known as "AN ORDINANCE EFFECTINE THE DEMOLITION OF THE POST OFFICE ESTABLISHED WITHIN THE MUNICIPAL HALL OF THIS MUNICIPALITY".

SECTION II. ORDAINING CLAUSE: That the Office of the Postal Services above-described shall be demolished for renovation and to be utilized for the Community Electronic Center (Internet) of this local government unit.


SECTION III. ADMINISTRATIVE PROVISION: That the post office herein mentioned shall be cancelled in the Book of Accounts of the Local Government Unit of Siayan, Zamboanga del Norte and the same be accounted as the Community Electronic Center (Internet) after the completion of its renovation.


SECTION IV. EFFECTIVITY CLAUSE: The Ordinance shall take effect upon approval.
