

## PREFATORY STATEMENT

The Local Finance Committee of the Local Government Unit of this municipality has certified to the availability of funds amounting to P10,202,596.00 after receipt from the national government IRA difference and IRA monetization which is subject to budgeting hence this ordinance making the funds available therefore embodied in Supplemental Budget No. 04.

BE IT ORDAINED by the Hon. Sangguniang Bayan in session assembled:

SECTION I. TITLE. This shall be known as "AN ORDINANCE MAKING AVAILABLE THE AMOUNT OF P10,202,596.00 EMBODIED IN SUPPLEMENTAL BUDGET NO. 04 FOR VARIOUS EXPENDITURES OF THE LOCVAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE."
